VACCINE BASICS

As there are almost 25 million people in Australia that are needing vaccinations yearly, the Vaccines Scheme allows individuals to have a business that provides and administers vaccinations across the nation.

When you become a Vaccine Provider, you can receive free vaccinations to administer to those eligible under the National Immunisation Program (NIP). Time/administration fee will apply and can be claimed under the Medicare rebate as well.

In addition to this, providers can also purchase vaccines and charge privately, meaning the total cost consist of the vaccine and time/administration fee.

You can administer these free vaccines to eligible people, including young children, older Australians, Aboriginal and Torres Strait Islander people, and others who are at greater risk of serious harm from vaccine-preventable diseases such as pregnant women.

Additional vaccines may also be funded through state and territory programs

HOW TO REGISTER

Both the state and national governments have set requirements for providers to be eligible to register.

GOVERNMENT REQUIREMENTS INCLUDE:

- Have an Australian Business Number (ABN).
- Develop a range of legal documents in line with legislation such as policies, registers, procedures, staff forms and client forms.
- Satisfy state registration requirements.
- Obtain a Vaccine provider number with the Australian Immunisation Register.
- Have the appropriate key personnel in place.
- Required equipment such as a specialised refrigerator, data loggers, thermometers etc.
